

Sunshine Plaza's Spring Fest School Holiday Event - Terms and Conditions including the Privacy Statement

Terms & Conditions

1. The Promoter is Lendlease Property Management (Australia) Pty Ltd of Level 14, Tower Three, International Towers Sydney, Exchange Place, 300 Barangaroo Avenue, Barangaroo, NSW, Sydney 2000 (Lendlease). Contact number is 1800 233 066.
2. Information on booking a ticket to Spring Fest at Sunshine Plaza forms part of these terms and conditions.
3. Registration is only valid for parents or guardians for participants aged 3+.
4. The Spring Fest is available at Sunshine Plaza from Tuesday 21 – Saturday 25 September and Tuesday 28 September – Saturday 2 October 2021 as per the following timetables.

5. There will be 10 sessions available in total, with 100 tickets available per session (total of 1000 tickets). Once the 10 sessions have reached maximum capacity, there will be no additional tickets or sessions provided.
6. For a customer to book a ticket to Spring Fest, he or she must visit the Eventbrite listing or by visiting the Customer Service Desk at Sunshine Plaza and completing the online booking registration using the supplied iPad. At the time of registration, the participant will be required to provide their full name, phone number and email address. Each ticket will incur a cost of \$5.00AUD which is payable in full at the time of booking via the online payment gateway within the Eventbrite listing. No cash will be accepted as payment.
7. Each Spring Fest ticket will entitle the ticket holder to:
 - a. One-time access to the Spring Fest Zone, located in Centre Court, West Mall at Sunshine Plaza;
 - b. 1 x craft activity (Week 1: Fabric Wind Spinner or Paper Wind-Mill; Week 2: Mini Flower Pot);
 - c. Choice of 1 x balloon figure or 1 x glitter tattoo;
 - d. 1 x serve of Fairy Floss
 - e. 1 x Spring Fest Lanyard

9. Confirmation of registration to attend the customer's nominated session will be issued to the customer by email immediately after the registration takes place.

Such proof of identity as may be directed by the Promoter may be required.
15. If you notify us of a cancellation less than 24 hours prior to your scheduled session or you fail to show up to your session, then you will forfeit the entitlement to a \$5.00AUD refund which will be donated to Salty Souls Legacy ABN 42 639 120 308.
16. Once a ticket has been confirmed, ticket/s are unable to be transferred or changed to a session on a different day.
17. The Promoter its agents and contractors shall not be liable for any loss or damage whatsoever which is suffered or for personal injury which is suffered or sustained as a result of your attending the Spring Fest except for any liability which cannot be excluded by law.

 - c. promptly cancel all bookings received via Eventbrite and issue refunds; and
 - d. not use the personal information you have provided on the booking registration.
