

SUNSHINE PLAZA – “APRIL 2026 SUNSHINE TICKET”
TERMS AND CONDITIONS

1. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promoter is GPT Management Holdings Limited ABN 67 113 510 188 Level 51, 25 Martin Place, Sydney, NSW 2000 Australia. (“**Promoter**”).
3. This promotion will be conducted at Sunshine Plaza, 154-164 Horton Parade, Maroochydore QLD 4558 (“**Centre**”).

KEY TERMS OF ENTRY

4. An *APRIL 2026 SUNSHINE TICKET* will cost the individual \$42.00 and is valued at up to \$90.10.
5. An *APRIL 2026 SUNSHINE TICKET* will be available for purchase:
 - a) by eligible Presale registered individuals from Monday 2 March until Wednesday 4 March 2026 (the “**Presale Purchasing Period**”); and
 - b) by general public sale from Thursday 5 March until Sunday 26 April 2026 (the “**General Purchasing Period**”), or while stocks last.
6. An *APRIL 2026 SUNSHINE TICKET* can be collected at Sunshine Plaza from 9AM Monday 23 March until 4PM Sunday 26 April 2026 (the “**Promotion Period**”).
 - a) To be eligible for the Presale Purchasing Period, individuals must visit <https://www.sunshineplaza.com/what-s-on/sunshine-ticket> at any time between 9AM Thursday 19 February and 11.59PM Sunday 1 March 2026 (the “**Presale Registration Period**”) and complete the Registration Form.
7. Individuals who have completed the Registration Form during the Presale Registration Period will receive an email to the individual’s registered email address on Monday 2 March 2026 with their Presale Access Code.
8. To purchase and collect an *APRIL 2026 SUNSHINE TICKET* during the Presale Purchasing Period, individuals must complete the following steps during the Presale Purchasing Period:
 - a) Visit <https://www.sunshineplaza.com/what-s-on/sunshine-ticket> to purchase their ticket/s.
 - b) Once the Humanitix *APRIL 2026 SUNSHINE TICKET* page loads, enter the Presale Access Code emailed on Monday 2 March 2026 to the individual’s email address registered during the Presale Registration Period.
 - c) Select ‘Buy Tickets’.
 - d) Select the number of *APRIL 2026 SUNSHINE TICKET* they wish to purchase.
 - e) Complete the relevant fields including contact details, user details and credit card information.
 - f) Present the confirmation email and QR code to the Customer Service Desk to collect their *APRIL 2026 SUNSHINE TICKET* during the “Promotion Period”.
 - g) Present their *APRIL 2026 SUNSHINE TICKET* to Participating Retailers to redeem their offer (valid during the “Promotion Period”).
9. To purchase and collect an *APRIL 2026 SUNSHINE TICKET* during the General Purchasing Period, individuals must complete the following steps during the General Purchasing Period:

 - b) Once the Humanitix *APRIL 2026 SUNSHINE TICKET* page loads, select ‘Buy Tickets’.
 - c) Select the number of *APRIL 2026 SUNSHINE TICKET* they wish to purchase.
 - d) Complete the relevant fields including contact details, user details and credit card information.
 - e) Present the confirmation email and QR code to the Customer Service Desk to collect their *APRIL 2026 SUNSHINE TICKET* during the “Promotion Period”.
 - f) Present their *APRIL 2026 SUNSHINE TICKET* to Participating Retailers to redeem their offer (valid during the “Promotion Period”).

GENERAL TERMS AND CONDITIONS

10. Participating Retailers (“**Participating Retailers**”) include BBC Cinemas, Timezone, Plaza Pontoon, Betty’s Burgers, Gelatissimo, Archer Coffee & Bagels, Brooklyn Donut & Coffee Co, Cinnabon, Coca Bar, Mocha Melody, Muffin Break, San Churro and Shingle Inn at Sunshine Plaza only.
11. If, for any reason, the Purchaser does not redeem or use their *APRIL 2026 SUNSHINE TICKET* during the specified Promotion Period, the *APRIL 2026 SUNSHINE TICKET* will be deemed invalid and cash or other prizes will not be offered in replacement.
12. *APRIL 2026 SUNSHINE TICKET* is not transferable or exchangeable and cannot be taken as cash, unless otherwise specified.

The Promoter is not responsible for receipt of incorrect, inaccurate or incomplete information either caused by website users or by any of the equipment used, or by any computers or technology used by intermediaries, service providers, or business partners to facilitate the campaign.
18. By purchasing an *APRIL 2026 SUNSHINE TICKET*, Purchasers are providing consent for the Promoter to hold and use their personal information.
19. If for any reason the Promotion cannot be implemented as planned (whether caused by infection by computer virus, line drop out, bugs, tampering, unauthorised intervention, fraud, technical failures or any other cause beyond the control of the Promoter which corrupts or affects the administration, security, fairness or integrity of the offer), the Promoter reserves the right in its sole discretion, (subject to any written direction given by a relevant regulatory authority), to cancel, terminate, modify or suspend the offer. The Promoter may in its sole discretion disqualify any individual who tampers with the purchasing process.
20. Any cost associated with accessing the website/Humanitix page is the Purchasers responsibility and is dependent on the Internet service provider used.
21. Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in QLD (“**Non-Excludable Guarantees**”). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.
22. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter’s control); (b) any theft, unauthorised access or third party interference; (c) any purchase that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in ticket value to that stated in these Terms

and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) taking/use of a ticket.

23. Should the Purchaser's contact details change during the Purchasing Period or the Promotion Period, it is the Purchaser's responsibility to notify the Promoter. A request to access or modify any information provided in an entry must be directed to the Promoter only.
24. Entrants must retain their confirmation email, ticket email and tax invoice(s) from Humanitix as proof of purchase. Failure to produce the proof of purchase for all entries when requested may, in the absolute discretion of the Promoter, result in invalidation of the individuals purchases and forfeiture of any right to their *APRIL 2026 SUNSHINE TICKET*.
25. The Promoter's decision in relation to any aspect of the *APRIL 2026 SUNSHINE TICKET* is final and binding.
26. Change of mind refunds are not permitted. In the event that a Purchaser is no longer able to attend due to medical or health reasons, the Purchaser will need to contact Sunshine Plaza Centre Management and provide relevant documentation. Refunds will be reviewed on a case by case basis.
27. The Promoter reserves the right, at any time, to verify the validity of purchases and the purchaser (including a purchaser's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the purchasing process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper payments of the *APRIL 2026 SUNSHINE TICKET*. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
28. If there is a dispute as to the identity of a purchaser, the Promoter reserves the right, in its sole discretion, to determine the identity of the purchaser.
