Sunshine Arts Fest 2023 Terms and Conditions

How to enter - schools:

Sunshine Arts Fest (Promotion)

- a) Information on how to enter forms part of these terms and conditions.
- b) Entry is only open to currently enrolled students of the following schools (School):
 - Caloundra State High School
 - Kawana Waters State College
 - Montessori International College
 - Pacific Lutheran College
 - St Andrews Anglican College
 - Sunshine Coast Grammar School
- c) Employees of the Promoter and their immediate families are ineligible to enter.
- d) The Promotion commences at 9.00am EST on Monday 6 March 2023 and closes at 5.30pm EST on Monday 17 July 2023 (**Promotion Period**).
- e) To enter, each School must prepare one installation (**Entry**) which is built within the supplied specifications and incorporates the supplied surfboard prop.
- f) Each entry must incorporate both visual merchandising elements and the use of augmented reality technology.
- g) Each Entry will be showcased in centre at Sunshine Plaza, from Thursday 8 June 2023 to Sunday 23 July 2023. Judging and public voting will be open from 9am Thursday 8 June 2023 to 5.30pm Monday 17 July 2023 (Voting Period). After the Voting Period closes, voting for each Entry will cease and no further votes can be cast.
- Public Vote the Entry with the highest public Votes will be awarded the Judges Choice prize. The decision is final, and no correspondence will be entered into. The public Voting Period will be open from 9am Thursday 8 June 2023 to 5.30pm Monday 17 July 2023.
- Judges Choice this is a game of skill and chance plays no part in determining the Judges Choice winner. Each Entry will be individually judged based on creative merit. Judges decision is final and no correspondence will be entered into.
- j) Entries must adhere to the following guidelines or risk disqualification:
 - (i) The art display must follow the theme of 'Let the Sunshine in', include the provided 'surfboard' prop, incorporate elements of both augmented reality (AR) technology and visual merchandising techniques, in accordance with the judging criteria.
 - (ii) The art display must not include discriminative themes, offensive language, or icons.
 - (iii) The art display must keep within the allowable working platform of 2,000mm wide x 1,800mm deep x 75mm high, plus a backboard of 2,000mm wide x 1,800mm high. The promotor accepts no responsibility for any personal injury, death or property damage that arises out of or in connection with the construction or installation of each School's display.
 - (iv) Any fixed elements that are either suspended off the ground/for, or on the backdrop, within the display area, must be securely fixed, and must not weigh more than 2.5kg.
